# **ACCORD Holds Open House**

Preview of the Up and Coming 1960s Commemorative Civil Rights Museum held on Dr. Martin Luther King, Jr.'s National Birthday

**T**here were many activities taking place on January 20<sup>th</sup>, 2014, one of which was sponsored by ACCORD, Inc.: the **Open House** preview of the up and coming 1960s Commemorative Civil Rights Museum located at 79 Bridge Street. The Rudcarlie Building was built in the 1950's by Dr. Rudolph N. Gordon (1901-1959) and named for the members of his family Rudolph, Carlotta, and Rosalie. It was the first medical/dental office constructed in St. Augustine without racially segregated waiting rooms.

After Dr. Gordon's death, the office was rented to Dr. Robert B. Hayling, a dentist who became a prominent leader of the civil rights movement in St. Augustine. Many of the planning sessions for the movement were held here, with Dr. Martin Luther King, Jr. and others. On one occasion, the owner of a local tourist attraction came to the office with a gun and said he intended to kill Dr. King, "but I can't do it, because when I look at you, I see that you are a God-sent man." Lawyers who came to support the civil rights efforts made this building their headquarters as well. Two of them--Alvin J. Bronstein and Ralph Temple--were honored by ACCORD when they returned to the Ancient City in 2005.

Dr. Gordon's widow, Mrs. Rosalie Gordon-Mills (1907-2004) made history in 1965 when she became the first black woman in 400 years to seek public office in St. Augustine, as a candidate for the City Commission.

The Program began at 2 PM but guests started coming in around 1 PM to view the displays set up by ACCORD, Inc. and to take first-hand look at the building which was vacant for a number of years, then brought back to life by ACCORD Members.

Two special presentations were made to ACCORD Inc. for the museum by the <u>Wells Fargo Bank</u> and the <u>Willits Book Trust</u> of Philadelphia, Pa.

The open house included the **Big Check** presentation of a \$5,000 grant from Wells Fargo in support of ACCORD's Civil Rights Museum Project. The bank recently opened a banking store at 31 King St., site of the former Woolworth Building where significant civil rights activities took place. ACCORD placed a historic civil rights marker there in 2007 which inscription reads in part: "The Ponce de Leon Shopping Center opened in 1955 ... designed by Morris Lapidus (1902-2001), Florida's most famous mid-20th century architect ... only example of his work in the Ancient City ... anchored by a Woolworth's store on the west side (the door handles still say Woolworth's) ... Feb. 1, 1960, black college students in Greensboro, N.C., began a sit-in at their Woolworth's lunch counter to protest racial discrimination. Their example electrified the south, and just a few weeks later, students from Florida Memorial College in St. Augustine began sitting-in at this Woolworth's lunch counter ... summer of 1963, local ... students sat-in ... were arrested ... judge wanted them to end their participation in the civil rights effort ... spent the next six months in jail and reform school ... case of the St. Augustine Four — Audrey Nell Edwards, JoeAnn Anderson, Samuel White and Willie Carl Singleton — received national publicity as an example of injustice ... finally the governor and cabinet of Florida ordered them released ... January 1964. Dr. Martin Luther King, Jr. and Jackie Robinson hailed the St. Augustine Four as heroes of the civil rights movement."

#### Willits Trust

The Willits Philadelphia Yearly Meeting of the Religious Society of Friends (Quakers) presents books and media that embody Quaker values and core beliefs to emerging and established organizations that serve African-American communities in the southern region of the United States and throughout the country of Liberia.

By identifying and building partnerships with qualifying schools, libraries, museums and community centers, the Trust supports the efforts of local groups to preserve their African-American heritage and spirituality and keep the story of the

Civil rights movement and Underground Railroad alive for coming generations. The trust was originally established through the will of Charles L. Willits, a Quaker farmer and abolitionist from southern New Jersey, in 1885 who left funds to be used "for the distribution of religious tracts and writings of Friends ... one half of which shall be distributed among the colored people of the Southern States of the United States, and the remainder in the colony of Liberia; so that religion and morality may be promoted."

In re-interpreting the fund's mission for the 21st century, the Willits Book Trust carries out its mission by presenting gifts of books, designed to rekindle historic ties between Quakers and African-American communities, while fostering new connections and friendships.

Four members of the Willits Book Trust Committee traveled to St. Augustine to present books to the city's emerging Museum of Civil Rights, a project of the Accord Freedom Trail. They included: Charles Woodson, clerk of the Willits Book Trust, and member of Germantown Monthly Meeting; Vivian Rankin, of Lansdowne Monthly Meeting; Walton C. Burwell, of Germantown Monthly Meeting and Lisa Stewart Garrison, of Greenwich Monthly Meeting. The books that were presented included multiple copies of books for young people, each of which was selected by board members and volunteers involved in planning the Civil Rights Museum for St. Augustine. A Greeting was read by Charles Woodson from Dr. Gail Blattenberger of Salt Lake City Utah, to those present. A Special thank you also to Gail's mother, Ruth Blattenberger for believing in our cause.
