Attorney Dan Warren Receives the 2009 Harry T. and Harriette V. Moore Award by the Florida Historical Society

Prestigious Award given for his book relating to Florida's ethnic groups or dealing with significant social issues



Attorney Dan Warren author of <u>If It Takes All Summer: Martin Luther King</u>, the KKK, and States' Rights in St. Augustine, 1964 received the *2009 Harry T. and Harrieette V. Moore Award*. This award was presented to him at the Florida Historical Society Annual Meeting Awards Luncheon in Pensacola, FL, on May 21st.

The Moore's home was fire bombed on Christmas Eve, 1951, in Mims Florida, by the KKK. It was a most fitting award since while Dan was in law school he had talked with the FBI agent assigned to the case. In fact, that agent later became the local sheriff. The agent told Dan that he thought he knew who had killed the Moores back in 1951.
