Activists Retrace Their Steps On the Freedom Trail



Maude Burroughs Jackson and William 'Bill' Jacoby marched together in 1964 and decided to retrace their steps during a tour of the "Freedom Trail".

Maude Burroughs was a student at Florida Normal and Industrial College in 1964. The administration there warned the students to not take part in the non-violent demonstrations led by Dr. Robert B. Hayling, Dr. Martin Luther King, Jr., and the Southern Christian Leadership Conference or risk expulsion. That warning was not heeded by Maude. She attended the local rallies and went on the marches. She eventually was jailed numerous times. Those arrests almost led to her not being able to graduate.

Maude recalled her mother watching television one night and recognized her daughter as one of the students being arrested. Her mother was highly upset. Nonetheless, Maude was extremely proud to be a participant. Many years had passed and one day in 2012 Maude mentioned to Gwendolyn Duncan that there was a young white teenage student who marched alongside her during the marches to the downtown Slave Market. She wondered whatever became of him. Gwen agreed to mention his name to David Nolan, local historian, to see whether or not he could locate him. David called Gwen with a number and an article about Maude's marching companion. Gwen called, "William 'Bill' Jacoby" and talked with him, mentioning Maude Burroughs, with whom he recognized the name immediately. He asked how Maude was doing. Then Gwen put them in touch with one another.

Maude and Bill got in touch by telephone. Bill agreed to come to Middleburg to reunite with her. In the meantime Gwen was busy scheduling a tour for them of the Freedom Trail in St. Augustine.

The reunion proved to be a wonderful event. Eventually a second meeting took place August 6, 2013 to retrace their steps made during the spring of 1964.

Bill, Maude, and her sister were given a personal tour of the Freedom Trail and other sites relevant to the Civil Rights Movement of St. Augustine. The tour began at 55 Oneida Street where Maude recalled being in Dr. Hayling's

From 55 Oneida Street, Bill and Maude went around to the front of Dr. Hayling's office which he recognized. He was only 18 years of age and a sophomore, at Dartmouth College, during the spring of 1964. The Civil Rights
